POLICIES AND GUIDELINES

A booth location will be assigned by AIR OPERATIONS, a representative will show you to your designated space upon arrival. It is recommended that Commands/Squadrons/Units set up on the Thursday practice day before sunset. Flight Line MUST be clear of all vehicles by 7:30 a.m. on Friday, May 9, 2025.

A list of all items and prices must be submitted along with the application form for approval. Command/Squadron/Unit will be notified via email if application has been approved.

Booth Space

- Limit one command/unit per booth.
- Booth space will be provided at no charge and will consist of one (1) 10.ft. by 10-ft. space by your static display. Tent, tables and chairs will not be provided.
- Any required signage must be provided by the command/squadron/unit. Signage is limited to one (1) banner (NTE 3-ft. by 6-ft.). Command/squadron/unit name and prices are to be on displayed signage.
- Command/squadron/unit is responsible for decorating space. Balloons and inflatables are NOT permitted.
- Electricity and water will not be available.
- Use of commercial entities for the sale of any item is NOT permitted.

Booth Operations

- Commands/squadrons/units are responsible for providing their own change fund.
- Booths should not be left unattended at any time.
- Commands/squadrons/units should conceal and properly secure all valuable items.
- Commands/squadrons/units are responsible for the conduct and personal appearance of all personnel in their designated booth.
- Consumption of alcohol is NOT permitted in or around the designated booth. There is NO smoking in the booth area or on the Flight Line. Designated smoking areas are available.
- NAS Corpus Christi and NAS Corpus Christi MWR are not responsible for any loss or damage to any items.

- Absolutely NO sales or distribution of food or beverage. Fundraising is NOT permitted.
- Do not play loud music in your tent/display area.
- Promotional material may not be distributed on the grounds.
- The use of the NAS Corpus Christi Wings Over South Texas Air Show logo is not permitted.
- Tip jars, raffles, free giveaway or soliciting for donations is NOT permitted.
- Patrons shall not be charged for photos with member in government uniforms, flight gear or equipment.
